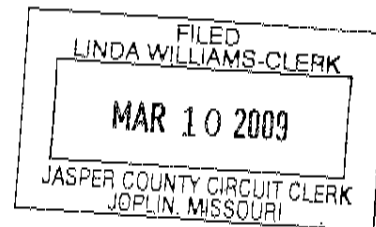

**FINAL JUDGMENT**

Having carefully considered Plaintiffs' motion and supplemental motion for attorneys' fees and costs and their motion for pre- and post-judgment interest, and having carefully considered Defendants' motions for judgment notwithstanding the verdict or in the alternative for new trial or remittitur, the Court hereby

ORDERS, ADJUDGES and DECREES that Defendants' motions are overruled, that Plaintiffs' motions are granted in part and overruled in part, that Plaintiffs are awarded attorneys' fees in the amount of \$114,540 together with costs in the amount of \$2,998.20 and that Plaintiffs are awarded prejudgment interest on all of the judgment (as outlined below) except 50% of punitive damages, which are payable to the State of Missouri. The Court further ORDERS, ADJUDGES and DECREES that final judgment

is hereby entered for the Plaintiffs and against Defendants, in accordance with the jury's verdict and this Court's judgment on November 5, 2008, as follows:

In favor of Plaintiff Hillary Woods and against Defendants Scorpio Supply IV, LLC d/b/a NAPA Auto Parts of Joplin, Defendant Jim Entrikin and Defendant Alvin Briscoe, jointly and severally in the sum of \$10,000.00 plus \$58,769.10 (one-half of the total attorneys' fees and costs), for a total of \$68,769.10 plus prejudgment interest (at a rate of 5.0%) in the amount of \$1,987.62, for a total judgment against these defendants of \$70,756.72. In accordance with Mo. Rev. Stat. § 408.040.2, interest on the total judgment will accrue at the rate of 5.25% per year beginning on the date this judgment is entered until it is satisfied in full.

In favor of Plaintiff Heather Haiar and against Defendants Scorpio Supply IV, LLC d/b/a NAPA Auto Parts of Joplin, Defendant Scorpio Supply III, LLC d/b/a NAPA Auto Parts of Monett, Defendant Jim Entrikin and Defendant Alvin Briscoe, jointly and severally in the sum of \$10,000.00 plus \$58,769.10 (one-half of the total attorneys' fees and costs), for a total of \$68,769.10 plus prejudgment interest (at a rate of 5.0%) in the amount of \$1,987.62, for a total judgment against these defendants of \$70,756.72. In accordance with Mo. Rev. Stat. § 408.040.2, interest on that total judgment will accrue at the rate of 5.25% per year beginning on the date this judgment is entered until it is satisfied in full.

In favor of Plaintiff Hillary Woods and against Defendant Scorpio Supply IV d/b/a NAPA Auto Parts of Joplin in the sum of \$50,000.00 plus prejudgment interest (at a rate of 5.0% on half that amount) in the amount of \$721.62, for a total judgment against that defendant of \$50,721.62. In accordance with Mo. Rev. Stat. § 408.040.2, interest on

\$25,000.00 plus the prejudgment interest amount of \$721.62, or a total of \$25,721.62, will accrue at the rate of 5.25% per year beginning on the date this judgment is entered until it is satisfied in full.

In favor of Plaintiff Hillary Woods and against Defendant Jim Entrikin in the sum of \$25,000.00 plus prejudgment interest (at a rate of 5.0% on half that amount) in the amount of \$380.81, for a total judgment against that defendant of \$25,360.81. In accordance with Mo. Rev. Stat. § 408.040.2, interest on \$12,500.00 plus the prejudgment interest amount of \$360.81, or a total of \$12,860.81, will accrue at the rate of 5.25% per year beginning on the date this judgment is entered until it is satisfied in full.

In favor of Plaintiff Hillary Woods and against Defendant Alvin Briscoe in the sum of \$50,000.00 plus prejudgment interest (at a rate of 5.0% on half that amount) in the amount of \$721.62, for a total judgment against that defendant of \$50,721.62. In accordance with Mo. Rev. Stat. § 408.040.2, interest on \$25,000.00 plus the prejudgment interest amount of \$721.62, or a total of \$25,721.62, will accrue at the rate of 5.25% per year beginning on the date this judgment is entered until it is satisfied in full.

In favor of Plaintiff Heather Haiar and against Defendant Scorpio Supply IV d/b/a NAPA Auto Parts of Joplin and Defendant Scorpio Supply III d/b/a NAPA Auto Parts of Monett in the sum of \$50,000.00 plus prejudgment interest (at a rate of 5.0% on half that amount) in the amount of \$721.62, for a total judgment against that defendant of \$50,721.62. In accordance with Mo. Rev. Stat. § 408.040.2, interest on \$25,000.00 plus the prejudgment interest amount of \$721.62, or a total of \$25,721.62, will accrue at the rate of 5.25% per year beginning on the date this judgment is entered until it is satisfied in full.

In favor of Plaintiff Heather Hajar and against Defendant Jim Entrikin in the sum of \$25,000.00 plus prejudgment interest (at a rate of 5.0% on half that amount) in the amount of \$360.81, for a total judgment against that defendant of \$25,360.81. In accordance with Mo. Rev. Stat. § 408.040.2, interest on \$12,500.00 plus the prejudgment interest amount of \$360.81, or a total of \$12,860.81, will accrue at the rate of 5.25% per year beginning on the date this judgment is entered until it is satisfied in full.

In favor of Plaintiff Heather Hajar and against Defendant Alvin Briscoe in the sum of \$50,000.00 plus prejudgment interest (at a rate of 5.0% on half that amount) in the amount of \$721.62, for a total judgment against that defendant of \$50,721.92. In accordance with Mo. Rev. Stat. § 408.040.2, interest on \$25,000.00 plus the prejudgment interest amount of \$721.62, or a total of \$25,721.62, will accrue at the rate of 5.25% per year beginning on the date this judgment is entered until it is satisfied in full.
